LINDA H. AIKEN, PhD, RN, is director of the Center for Health Outcomes and Policy Research, the Claire M. Fagin Leadership Professor of Nursing, professor of sociology, and senior fellow at the Leonard Davis Institute of Health Economics at the University of Pennsylvania. She is a member of the Institute of Medicine of the National Academy of Sciences, the American Academy of Arts and Sciences, and the National Academy of Social Insurance; a fellow and former president of the American Academy of Nursing; and an honorary fellow of the United Kingdom's Royal College of Nursing. Dr. Aiken is the winner of the 2003 Individual Earnest A. Codman Award from the Joint Commission on Accreditation of Healthcare Organizations.

DAVID C. COLBY, PhD, is deputy director of the Health Care Group at The Robert Wood Johnson Foundation. He came to the foundation in 1998 after nine years of service with the Medicare Payment Advisory Commission and the Physician Payment Review Commission, most recently as deputy director. Dr. Colby was a Robert Wood Johnson Faculty Fellow in Health Care Finance, serving in the Congressional Budget Office. His published research has focused on Medicaid and Medicare, media coverage of AIDS, and various topics in political science.

NORMAN DANIELS, PhD, is professor of ethics and population health at Harvard School of Public Health. His most recent books include *From Chance to Choice: Genetics and Justice* (with Allen Buchanan, Dan Brock, and Dan Wikler, Cambridge University Press, 2000); *Is Inequality Bad for Our Health?* (with Bruce Kennedy and Ichiro Kawachi, Beacon Press, 2000); and *Setting Limits Fairly: Can We Learn to Share Medical Resources?* (with James Sabin, Oxford University Press, 2002). Dr. Daniels is a fellow of the Hastings Center, a member of the Institute of Medicine, and a founding member of the National Academy of Social Insurance and the International Society for Equity in Health.

RICHARD G. FRANK, PhD, is the Margaret T. Morris Professor of Health Economics in the Department of Health Care Policy at Harvard Medical School and a research associate with the National Bureau of Economic Research. Dr. Frank serves on the Biobehavioral Sciences Board of the Institute of Medicine and is the co-editor of the *Journal of Health Economics*. He was awarded the Georgescu-Roegen Prize from the Southern Economic Association for his collaborative work on drug pricing, the Carl A. Taube Award from the American Public Health Association for outstanding contributions to mental health services and economics research, and the Emily Mumford Medal from Columbia University's Department of Psychiatry.

SHERRY A. GLIED, PhD, is professor and chair of the Department of Health Policy and Management of Columbia University's Mailman School of Public Health. In 1992–1993, she served as a senior economist for health care and labor market policy on the president's Council of Economic Advisers under Presidents Bush and Clinton and participated in the Clinton Health Care Task Force. Professor Glied's principal areas of research are in health policy reform and mental health care policy. Her book on health care reform, *Chronic Condition*, was published by Harvard University Press in January 1998.

DAVID HEMENWAY, PhD, is professor of health policy at Harvard School of Public Health, where he has won more teaching awards than any other faculty member. Dr. Hemenway is director of the Harvard Injury Control Research Center and the Harvard Youth Violence Prevention Center. He is the author of *Private Guns, Public Health* (University of Michigan Press, 2004).

LISA I. IEZZONI, MD, MSc, is professor of medicine at Harvard Medical School and codirector of research in the Division of General Medicine and Primary Care, Department of Medicine, at Beth Israel Deaconess Medical Center in Boston. She has conducted numerous studies on risk adjustment and quality measurement methods and has edited *Risk Adjustment for Measuring Health Care Outcomes* (Health Administration Press, 2003), now in its third edition. Dr. Iezzoni recently published *When Walking Fails: Mobility Problems of Adults with Chronic Conditions* (Milbank Memorial Fund and University of California Press, 2003). She is a member of the Institute of Medicine of the National Academy of Sciences.

PATRICIA SELIGER KEENAN is a PhD candidate in health policy at Harvard University. Her dissertation focuses on the implications of the growth in spending on medical care. She previously held positions at the Henry J. Kaiser Family Foundation and the Health Care Financing Administration.

JAMES R. KNICKMAN, PhD, is vice president for Research and Evaluation at The Robert Wood Johnson Foundation, where he is responsible for external evaluation of national initiatives and developing research initiatives. Before joining the foundation's staff in 1992, Dr. Knickman was on the faculty at New York Univer-

sity and its Health Research Program, where he conducted research on a range of issues related to health care delivery. In addition to his position at The Robert Wood Johnson Foundation, Dr. Knickman is chair of the Board of Directors of the Robert Wood Johnson University Hospital in New Brunswick, New Jersey.

LUCIAN L. LEAPE, MD, is adjunct professor of health policy in the Department of Health Policy and Management at the Harvard School of Public Health. Before joining the Harvard faculty in 1988, he was professor of surgery and chief of pediatric surgery at Tufts University School of Medicine. Dr. Leape was a founder of the National Patient Safety Foundation, the Massachusetts Coalition for the Prevention of Medical Error, and the Harvard Kennedy School Executive Session on Medical Error. He was a member of the Institute of Medicine's Quality of Care in America Committee, which published *To Err Is Human* (National Academies Press, 1999) and *Crossing the Quality Chasm* (National Academies Press, 2001). He has published over one hundred papers on quality of care and patient safety.

BRUCE G. LINK, PhD, is professor of epidemiology and sociomedical sciences at Columbia University's Mailman School of Public Health and a research scientist at New York State Psychiatric Institute. He is director of the Psychiatric Epidemiology Training Program and the Center for Violence Research and Prevention at Columbia, and codirector of The Robert Wood Johnson Foundation's Health and Society Scholars Program. His interests include the nature and consequences of stigma for people with mental illnesses, the social epidemiology of homelessness, the connection between mental illnesses and violent behaviors, and explanations for associations between social conditions and morbidity and mortality.

THOMAS G. MCGUIRE, PhD, is professor of health economics at Harvard Medical School. His research focuses on the design and impact of health care payment systems, the economics of health care disparities, and the economics of mental health policy. Dr. McGuire is a member of the Institute of Medicine of the National Academy of Sciences and coeditor of the *Journal of Health Economics*. He received the 1998 Arrow Award (jointly with Albert Ma) from the International Health Economics Association and the 1991 Carl A. Taube Award from the American Public Health Association.

DAVID MECHANIC, PhD, is the René Dubos University Professor of Behavioral Sciences and director of the Institute for Health, Health Care Policy, and Aging Research at Rutgers, the State University of New Jersey. He also directs The Robert Wood Johnson Foundation's Investigator Awards in Health Policy Research and the National Institute of Mental Health's Center for Research on the Organization and Financing of Care for the Severely Mentally Ill at Rutgers. Dr. Mechanic is a member of the National Academy of Sciences, the American Academy of Arts and Sciences, and the Institute of Medicine. He has written or edited twenty-four books and some four hundred research articles, chapters, and other publications in medical sociology, health policy, health services research, and the social and behavioral sciences.

MICHAEL L. MILLENSON is the Mervin Shalowitz, MD Visiting Scholar at Northwestern University's Kellogg School of Management and a nationally recognized consultant on the quality of health care, on patient empowerment, and on e-health. He is the author of *Demanding Medical Excellence: Doctors and Accountability in the Information Age* (University of Chicago Press, 1997). A former Pulitzer Prize-nominated journalist, he has written for a range of peer-reviewed and general interest publications including *Health Affairs* and the *Washington Monthly*.

JAMES A. MORONE, PhD, is professor of political science at Brown University. His most recent book is *Hellfire Nation: The Politics of Sin in American History*, published by Yale University Press, 2003. Dr. Morone's *Democratic Wish: Popular Participation and the Limits of American Government* (Basic Books, 1990, Yale University Press, 1998) won the American Political Science Association's Gladys Kammerer Award for the best book on the United States and was named a "notable book of 1991" by the *New York Times*. He has written more than one hundred articles on American politics, history, and health care policy. The Brown University classes of 1993, 1999, and 2001 voted Dr. Morone the Barret Hazeltine Citation as teacher of the year.

JO C. PHELAN, PhD, is associate professor of sociomedical sciences at Columbia University's Mailman School of Public Health. Her research focuses on social inequalities, including objective conditions of inequality and social psychological factors that contribute to and result from those conditions. Her current research interests include socioeconomic disparities in health and mortality, and public attitudes and beliefs about mental illness, especially the potential impact of the genetics revolution on those attitudes.

JAMES C. ROBINSON, PhD, is professor of health economics and chair of the Division of Health Policy and Management at the University of California, Berkeley. His research focuses on medical groups, hospital systems, health insurance, health care consumerism, and capital finance. Dr. Robinson has published over seventy-five papers in peer-reviewed journals and two books through the University of California Press, *The Corporate Practice of Medicine* (1999) and *Toil and Toxics* (1991). He is a contributing editor to *Health Affairs* and a member of the board of directors of the Integrated HealthCare Association.

LYNN B. ROGUT, MCRP, is deputy director of The Robert Wood Johnson Foundation Investigator Awards in Health Policy Research. Before joining the Investigator Awards program, she served as executive director of the New York Center for Liver Transplantation, a consortium of liver transplant programs in New York State. She previously held positions at the United Hospital Fund, the SUNY Health Science Center at Brooklyn, and M. Bostin Associates, Inc. Her interests include quality of care and organ transplantation policies.

SARA ROSENBAUM, JD, is the Harold and Jane Hirsh Professor of Health Law and

Policy and chair of the Department of Health Policy at the School of Public Health and Health Services, George Washington University Medical Center. She also directs the Hirsh Health Law and Policy Program and the Center for Health Services Research and Policy. Professor Rosenbaum is coauthor of *Law and the American Health Care System* (Foundation Press, 1999). From 1993 to 1994, Professor Rosenbaum worked for the White House Domestic Policy Council, where she directed the drafting of the Health Security Act. She has been named one of America's five hundred most influential health policymakers and has been recognized by the U.S. Department of Health and Human Services for distinguished national service on behalf of Medicaid beneficiaries.

THEDA SKOCPOL, PhD, is the Victor S. Thomas Professor of Government and Sociology and director of the Center for American Political Studies at Harvard University. Her research focuses on the politics of U.S. social policies and on changing patterns of civic engagement in American democracy. Her most recent books include *Boomerang: Health Reform and the Turn against Politics* (W. W. Norton, 1996); *The Missing Middle: Working Families and the Future of American Social Policy* (W. W. Norton, 2000); and *Diminished Democracy: From Membership to Management in American Civic Life* (University of Oklahoma Press, 2003).

ROSEMARY A. STEVENS, PhD, MPH, is Stanley I. Sheerr Professor in Arts and Sciences, Emeritus, in the Department of History and Sociology of Science at the University of Pennsylvania. She has also served as a senior fellow at the Leonard Davis Institute of Health Economics and as dean of the School of Arts and Sciences at the University of Pennsylvania. Dr. Stevens's current research is on the impact and implications of specialization in American medicine. She is a public member of the American Board of Medical Specialties and a long-time member of the Institute of Medicine. She has published six books and numerous articles on the history of medicine and health policy research.

ALVIN R. TARLOV, MD, is a professor in the School of Public Health at the University of Texas and the Sid Richardson and Taylor and Robert H. Ray Senior Fellow in Health Policy at the James A. Baker III Institute for Public Policy at Rice University. Previously, he was professor of medicine at Tufts University, professor of health promotion at the Harvard School of Public Health, and president of the Henry J. Kaiser Family Foundation. Dr. Tarlov is a former Markle Foundation scholar and NIH Research Career Development awardee. He was elected to the Association of American Physicians and the Institute of Medicine and is a master of the American College of Physicians. From 1997 to 2000 he served as the national program director of the The Robert Wood Johnson Foundation's Investigator Awards in Health Policy Research.

JOEL TEITELBAUM, JD, LL.M., is associate professor and vice chair of the Department of Health Policy and managing director of the Hirsh Health Law and Policy Program at the School of Public Health and Health Services, George Washington

University Medical Center. His research interests include civil rights issues in health care, health care financing and delivery systems, and quality-of-care issues. Professor Teitelbaum serves on the Board of Directors of the Center for the Study of Race and Bioethics at DePaul University College of Law, and as a faculty mentor to Project HEALTH, a national student organization addressing socioeconomic, medical, and environmental causes of poor health in children who are disadvantaged.

KENNETH E. WARNER, PhD, is the Avedis Donabedian Distinguished University Professor of Public Health at the University of Michigan and director of the university's Tobacco Research Network. His research focuses on the economic and policy aspects of disease prevention and health promotion, with an emphasis on tobacco and health. Dr. Warner was a founding member of the Board of Directors of the American Legacy Foundation. In 1989 Dr. C. Everett Koop awarded him the Surgeon General's Medallion. In 2003, he received the inaugural award for Outstanding Research Contribution of the Luther L. Terry Awards for Exemplary Leadership in Tobacco Control. Dr. Warner is a member of the Institute of Medicine of the National Academy of Sciences.

DAVID R. WILLIAMS, PhD, is on the faculty at the University of Michigan, where he serves as the Harold W. Cruse Collegiate Professor of Sociology, senior research scientist at the Institute for Social Research, professor of epidemiology in the School of Public Health, and faculty associate in the Center for Afro-American and African Studies and the Program for Research on Black Americans. His previous academic appointment was at Yale University. He is interested in the trends and determinants of socioeconomic and racial differences in mental and physical health and has authored more than one hundred scholarly papers in scientific journals and edited collections. He is a member of the Institute of Medicine of the National Academy of Sciences.
